Jennings County Pre-K Program is an educational program that provides services for children age 4.

- ✓ A fun, safe, caring, and educational learning environment

- ✓ Cognitive – Thinking/reasoning skills, problem-solving
- ✓ Social /Emotional - coping skills
- ✓ Pre-K instruction is five days a week Monday- Friday
- ✓ Morning care will be available starting at 7:00 a.m. (Limited number)
- ✓ After care will be available until 4:00 p.m. (Limited number)



## **Pre-K Pricing**

- ✓ Full day Pre-K \$125/week with breakfast, lunch, and snacks included
- ✓ Voucher options available for families that make less than \$185,000 per year
- ✓ Morning and Aftercare also included in the weekly rate (limited space available)

## **Registration Requirements**

- ✓ Must be age 4
- ✓ Must be potty trained
- ✓ Birth Certificate
- ✓ Immunization Records
- ✓ Be able to provide own transportation
- ✓ Contact Information  
(for anyone authorized to drop off, transport, and pick up your child)
- ✓ Custody Papers (if applicable)
